

FACEBOOK #MorelandLibrariesGiveaway TERMS AND CONDITIONS

1. This giveaway is run by Moreland City Council ('Council') in the state of Victoria, Australia only. This giveaway is in no way sponsored, endorsed, administered by or associated with Facebook or Australian Booksellers Association.
2. By entering this giveaway, you agree to accept these terms and conditions of entry ('conditions'). If your entry does not comply with these conditions, it will not be valid for entry.
3. Entry is restricted to residents of Victoria aged 13 years and over. If you are aged under 18 years, you must obtain your parent or guardian's written consent to enter this giveaway. Consent forms are available to download from each competition post. Council staff, Councillors, contractors and their immediate families are not eligible to enter.
4. The giveaway opens on **Friday 15 January 2021** and closes on **Friday 29 January 2020 at 11:59pm** ('giveaway period'). Entries received outside of the giveaway period will not be accepted.
5. To enter the giveaway, entrants must complete the following steps during the giveaway period:
 - a) Post a photo in the comments of any post made by Moreland City Libraries on Facebook that features "Post eligible for Moreland Libraries Giveaway" in the post's description; and
 - b) ensure that your photo is of a 'book nook' (a place you are enjoying reading or listening to books while staying at home during lockdown) and includes the hashtag #MorelandLibrariesGiveaway. The photo should solely be of the 'book nook' and should not include images of any person or individual. Images of any person or individual will be removed and considered ineligible for the competition.
6. Entrants can enter the giveaway as many times as they like during the giveaway period, provided that each entry complies with these conditions.
7. Entries must not contain any objectionable, offensive, profane, insulting or inflammatory images or language. To ensure the privacy of entrants is protected, entries must not contain items which may lead to the release of personal information or identification such as, but not limited to, personal identification documents, postal correspondence, phone numbers, street signs, house numbers or if a person is under 18, school uniforms. Entrants should switch off their geolocation services before posting a photo. Council reserves the right to remove or delete and exclude from entry any photographs or comments which, in its reasonable opinion, breaches this condition.
8. By entering the giveaway entrants give Council and Moreland City Libraries the right to use the photo posted in whole or in part in perpetuity and in all media.

9. All images are shared at the entrant's discretion. Facebook is a public forum and Council is not able to prevent other users from repurposing posted images.
10. The giveaway winner will be selected by Council on **Monday 1 February 2021** online. One winner will be chosen to receive a \$20 Australian Booksellers Association voucher gift card ('prize'). The winner will be announced via Facebook post on **Tuesday 2 February 2021** and the winner will also be contacted by direct message on Facebook. 11. Council will select the winner through a random selection process and compliance with these conditions. All valid entries will be assigned a number and a random number generator will be used to select the winning entry. . This process will be witnessed and verified by at least 2 Council officers and the result page of the random number generator will be screen recorded. Council's decision is final, and no correspondence will be entered into.
12. The winner of the competition can redeem their gift voucher via pick up at any of Moreland City Libraries' physical locations.
13. If the winner cannot be contacted by **Tuesday 9 February 2021** Council may opt to conduct a further random selection process to determine a new winner. The selection process will be completed as outlined in condition 11.
14. Council may require the winner to provide evidence of their identity. If there is a dispute as to the identity of the winner, Council reserves the right, in its entire discretion, to determine the identity of the winner.
15. The prize is not transferable, exchangeable or redeemable for cash.
